Day Camp Fee:

Day camp fee is \$50 total per child. The fee covers all scheduled camp activities, water, and an afternoon snack for three days of fun. The fee does not include lunch.

Drop-off and pick-up is at Pipestem State Park Picnic Shelter B, located at the upper end of the Canyon Rim Center and Tramway parking area. A release form is attached.

Please Note: Each child should wear close toed shoes. Pack sunscreen, bug spray, and rain poncho/ rain gear for your child. Bring binoculars if possible. On Wednesday we wade in the Bluestone River and enjoy the swimming pool. A towel and bathing suit as well as shoes* for river wading is necessary. Day campers should have personal belongings clearly marked with last name.
